The undersigned also agree to indemnify and hold harmless the City of Paso Robles from all accidents, injuries, damages, liabilities, costs and expenditures, including but not limited to attorneys fees and cost of defense, which may occur by reason of use of the streets, parking lot, or the Park prior to, during or following the Market(s) activities. The undersigned also agree to indemnify and hold harmless the **Country Farm & Craft Market** (and its employees, officers and assigns), from all accidents, injuries, damages, liabilities, costs, expenditures, including but not limited to attorneys fees and cost of defense, which may occur by reason of use of the streets, parking lot, or the Park prior to during or following the Market(s) activities. The **Country Farm & Craft Market** provides only general liability insurance for each market activity. The general liability insurance only protects The Organization not individual members. The **Country Farm & Craft Market** strongly encourages its applicants/sellers/businesses to carry appropriate insurance(s) for their activities, and may require documentation of coverage. The undersigned agrees to cooperate with the **Country Farm & Craft Market** (employees or assigns) to investigate any written and signed substantial complaint against them, by a current seller or customer. Paid application fee does not guarantee space or the ability to sell at all times. The applicant /producer/business owner is responsible for any fines levied by any government agency on the individual applicant/ producer/business owner. If the negligence of the applicant/producer/business owner causes a fine to be levied against the Market Manager/Managers or **Country Farm and Craft Market**, the applicant /producer /business owner will also be held liable for that fine.

- a. I certify under penalty of perjury that as a Certified Producer I produce the products myself from raw materials and that I do not buy these products and resell or repackage them.
- b. If I am a Non-certified Producer, or sell some non-certified product I will mark my product with the point of origin.
- c. I am aware that if I offer for sale produce I did not grow, but purchased from an authorized packinghouse, my space must be in an area separated from the Certified Produce, and my product is secondary to Certified product. I must also mark my display table with the point of origin of the produce.
- d. The artist/crafter represented at the market must create the Art/Craft products.
- e. If I am in retail sales I must have a resale number from the State Board of Equalization and report my sales tax.
